INTRODUCTION - THE OIV AND SCOPE

The International Organisation of Vine and Wine (OIV) is an international intergovernmental organisation with a scientific and technical mandate. It is recognised as the global reference for the vine and wine sector. Founded in 1924, the OIV currently has 51 Member States, countries producing and consuming grapes and wine, which account for 85% of the world's vineyard surface area, 90% of global wine production and 75% of global wine consumption.

SCOPE is a new initiative within the framework of the OIV Strategic Plan aimed at two objectives:

- First, to leverage the unique position of the OIV as the international intergovernmental organisation vine and wine to bring together governments, international organisations, experts, producers and other stakeholders in productive conversations about the key challenges and opportunities facing the sector.
- Second, to gather the perspectives and priorities of stakeholders in order to inform the future works of the OIV and ensure that they are targeted towards the areas of highest importance.

The outcomes of the SCOPE will be compiled in a report to be distributed to participants and presented to the OIV's Scientific and Technical and Executive Committees for further consideration in the context of its future works.

SCOPE will be held over 1.5 days on 20 and 21 October. Day 1 will set the scene with high-level perspectives from key international players on the focus subjects: sustainability, trade and culture. Day 2 will be dedicated to working sessions to explore aspects of the focus subjects.

Each working session will consider a specific aspect of the focus subject. The objectives of the working sessions are:

- to share a range of perspectives from different stakeholders and identify key challenges and opportunities
- to encourage stakeholders to offer collaborative ideas and solutions
- to explore where the OIV can play a role within the framework of its mandate as a global scientific and technical reference body.
